MINUTES OF WILLACY COUNTY DRAINAGE DISTRICT NO. 1

On September 15, 2021 the Board of Directors of Willacy County Drainage District No. 1 met at the District's office in Lyford, Texas, after having given notice thereof as provided by law, with the following person's present, to-wit:

Terry Galle, President called meeting to order at 10:30 a.m. and presided,

- Minutes. The minutes of the August 25, 2021 meeting were presented and reviewed.
 The motion was made by Dan Klostermann and seconded by Daniel Vassberg that the minutes of the August 25, 2021 meeting be approved. Following a discussion, the motion unanimously carried.
- 2. Public Comment Period. There was no audience. No one submitted a public comment.
- 3. Lateral G Status Report.
 - 3.1 County widening and improvement between east line of Block 28, GCIC and U.S. Highway 77/I-69. The County still has not advised when work will commence.
 - 3.2. County widening and improvement of segment between FM 1018 and Hidalgo Main Drain.
 - a. Status: No change in stats since the August 11, 2021 meeting.
 - b. Consider and take action on any matters to finalize grant. No action required at this time.
- 4. TxDOT FM 1018 Improvement upgrade of drain crossings. TxDOT awarded the project at the end of August, 2021. Work should commence in October 2021.
- 5. Lateral E, Lateral E-1, and Lateral E-2 in Share 2. Consider and take action to engage surveyor to prepare a description of the drains. No action
- 6. Gate 630-L (Fred Gate) Pump. The tentative delivery date is now the end of October 2021.
- 7. Equipment-Excavator. The motion was made by Daniel Vassberg and seconded by Dan Klostermann to purchase one Caterpillar 326 Long Reach Excavator (60 foot boom) at a cost of \$293,289.77, which includes 60 month/5000-hour extended warranty, per Buy Board contract No. 597-19. Following a discussion, the motion unanimously carried.
