Terry Galle, President called meeting to order at 10:35 a.m. and presided,

- 1. Minutes. The minutes of the April 13, 2022 meeting were presented. The motion was made by Melvin Gay and seconded by Thomas Zdansky that the minutes of the April 13, 2022 meeting be approved. Following a discussion, the motion unanimously carried.
- 2. Public Comment Period. There was no audience. No one submitted a public comment.
- 3. Audit Report: Audit for Fiscal Year Ended December 31, 2021. Geary Berkman, CPA, resented the audit for the fiscal year beginning January 1, 2021 and ending December 31, 2021. Following a review of the audit, the motion was made by Thomas Zdansky and seconded by Daniel Vassberg that the Audit for Fiscal Year beginning January 1, 2021 and ending December 31, 2021 be accepted. Following a discussion, the motion unanimously carried.
- 4. May 7, 2022 Election. Glenn Wilde and Dan Klostermann have signed the required oath of office and statement.
- 5. Election of Board Officers. It was noted that Water Code § 49.054 requires an election of officers after a director's election. The motion was made by Daniel Vassberg and seconded by Thomas Zdansky that Terry Galle be elected President of the Board, Glenn Wilde be elected Vice-President of the Board, and Melvin Gay be elected Secretary of the Board. Following a discussion, the motion unanimously carried. The motion was made and seconded that the election of board officers be effective at the conclusion of this meeting. Following a discussion, the motion unanimously carried.
- 6. Lateral G Status Report.
 - 6.1 County widening and improvement between east line of Block 28, GCIC and U.S. Highway 77/I-69 is in the final phase of engineering. The project is scheduled to be put out for bids sometime in July of 2022.
 - 6.2. County widening and improvement of segment between FM 1018 and Hidalgo Main Drain [Joint Flood Control Project TWDB application No. 40069.]

- (a) Status report: Still waiting on completion of the Engineering Feasibility Report. It is scheduled to be completed by June 30, 2022, The Design Phase is scheduled to be completed by September 30, 2022.
- (b) Consider and take action on payment of required environmental/archeological study and any other required study not paid out of the grant. The County has agreed to pay half of the grant application study, which is \$25,000.00. The remaining balance of \$12,500.00 will be paid for by Willacy County Drainage District No. 1.
- (c) Consider and take action on any other matters, if any, required of this District respecting the grant. No other action is required at this time.
- 7. TxDOT FM 1018 Improvement upgrade of drain crossings at Laterals G (two rows of 5 foot x 5 foot box culverts), G-1, and C. Installation of the of the 5x5 box culverts has commended. TxDOT says that installation should be completed by June 1, 2022.

8. Equipment:

- 8.1 Caterpillar 326 Long Reach, Serial Number MFJ20042, has been delivered to Holt Equipment, Edinburg Site. The boom has to be attached. The machine should be delivered to the District by June 1, 2022.
- 9. Reports: Receive reports and make decisions respecting the subject of such reports including:
 - 9.1 Manager:
 - (a) Work accomplished since last meeting. Lateral "C" and Lateral "B" ditch work has been completed. Continuing with ditch mowing and preparing for 2022 Hurricane Season
 - (b) Hidalgo-Willacy Joint Venture Drain Weir No. 4 failure: HCDD No. 1 Manager says the engineering study and plans are almost complete. When completed, the project will be put for bids. No other action is required at this time.
 - (c) Willacy County Drainage District No. 2: Report on work accomplished presented. Continuing with ditch mowing and preparing for 2022 Hurricane Season.
